DISSERTATION

Aiding and Abetting: Foreign Aid and State Coercion.

This study demonstrates the effect of US foreign policy on the internal security dynamics of aid recipient states. I draw upon the international security and contentious politics literatures to analyze how US foreign assistance affects the ability of recipient countries to employ violence against their citizens. I argue that as a consequence of fungibility—the diversion of aid for use as a general government resource—foreign aid may increase the likelihood of state violence through its effect on the state's coercive capacity. I further hypothesize that the coercive effects of foreign aid are conditioned by the political institutions of the recipient state and its past history of conflict. I test this argument through multiple case studies and a time-series cross-national dataset of annual US bilateral foreign aid and various measures of state violence and repression for approximately 110 developing countries during the period of 1976 to 2008. This research links the study of political violence with the changing nature of international relations and provides considerable insight into international influences on intrastate conflict. Additionally, I provide an explanation for why failing states persist, despite the high levels of international assistance they receive, and further suggest that foreign aid undermines development by creating conditions propitious to increased political violence in recipient countries.
